- b) Similar class of work means "General Electrical work i.e. Original/Project Works". The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid.
- 1. The intending bidder must read the terms and conditions of CPWD-7 carefully, He should only submit his bid if he consider himself eligible and he is in possession of all the documents required3. Information and instructions for bidders will form part of NIT & to be uploaded on website.
- 2. Information and instructions for bidders posted on website shall form of bid document.
- 3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from www.dda.org.in or central public procurement portal https:// eprocure.gov.in/eprocure/app free of cost.
 - Those contracts not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class II digital signature to submit the bid.

The Executive Engineer/ELD-13 will get earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened. Note:-GST@18% (CGST@9% & SGST@9%) is to be levied alongwith tendering / processing fee from all the registered/not registered/ to be registered contractors. Proof of registration (if applicable) and the proof of payment and its scanned copy are to be uploaded.

- 5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website.
- 6. The intending bidder must have valid class-II digital signature to submit the bid.
- 7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 8. Contractor can upload documents in the form of JPG format and PDF format.
- 9. Contractor must ensure to quote rate of each item. In addition to this while selecting any of cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). However, if a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above / below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
- 10. Pre-Bid conference shall be held in the chamber of SE (E) at _____* on ___* to clear the doubt of intending tenderers, if any.
